

Water System Quality Concerns

- Defective water storage tank
- Inequitable billing
- Water quality complaints
- Aging distribution system


Article 1: Water Tank & Meters

- •From State and legal counsel, Town has a <u>mandate</u> to address defective tank this year.
- Tank repair is the preferred approach.
- Meters are a pre-requisite for USDA-RD funding and provide an opportunity for fair billing.

Article 2: Filtration & Water Mains

- Upgrade water quality through filtration.
- Improve water distribution in areas with deficiencies.
- •Article 2 will <u>only</u> move forward upon approval of Article 1 <u>and</u> upon being awarded USDA-RD grant.

Impact on Tax Rate

Article 1 Only

Articles 1 & 2

Adds to tax rate per \$100 approximately

1 cent per year

Adds to tax rate per \$100 approximately % cent per year





Impact on Water Users

Until the water meters are installed, water users will pay their regular water rate plus a base fee to cover the amount of the bond.

Article 1 Only	Articles 1 & 2	
Bond Amount ~\$12.50 per month (\$150 per year)	Bond Amount ~\$18.00 per month (\$214 per year)

- •Water tank repair must be underway in summer of 2018.
- •Should we receive USDA-RD funding, all projects must be completed prior to March 2021.
